

- Solid Balance Sheet, positive free cash flow, and clear visibility into near-term cash flows.
- · Adaptability to changing business environments.
- Brand Recall & Market Dominance backed by a visible economic moat.
- Cost Efficiency: Enables efficient product & service delivery.
